MESSAGE FROM THE CHAIRPERSON

It has been another 12 months of turbulence for Darkinjung as we operated through the unprecedented consequences of COVID-19. None of us could have predicted the ongoing challenges we would face in the year coming, however I am proud of our organisation's strength, resilience and determination.

Public health orders continued to make it mandatory for us to close our office doors, postpone some of our planned operations and meetings to embrace new ways to achieve our mandate – including through an increased online presence to connect and communicate with our members and the broader community. Despite such trials and tribulations, Darkinjung has continued to deliver outcomes for our community, especially during the short periods of time where health orders were relaxed.

During the 2020/2021 period, Darkinjung has reinforced our cultural authority on the Central Coast, responding to misleading claims within the community in connection to our developments and also through the welcomed announcement that Darkinjung would be one of the first to deliver on a new pilot program with Transport New South Wales to receive a series of six unique road signs connecting road users to country.

We continued to make significant progress with our plans to develop and implement the Darkinjung Delivery Framework, a pipeline of sites that we have prioritised to realise our economic, social, cultural, and environmental aspirations. Whilst rolling out a series of online videos - Darkinjung Ngura, which explored Darkinjung Country and our connection – physical, spiritual and




cultural - to the lands on which we walk.


In addition, we cemented our relationship with the 5 Lands Walk through the signing of a memorandum of understanding to ensure Darkinjung's involvement throughout this important event on the Central Coast. This will guarantee that Darkinjung and Aboriginal culture more broadly is intrinsic to the event for years to come.

A very exciting and long-awaited achievement throughout the last year was the opening of Gosford Leagues Club Park in February 2021. Darkinjung played a central role in the park's design, working in close partnership with the Hunter Central Coast Development Corporation and landscape architects Turf Design. Darkinjung's involvement ensured that culture was at the heart of the park and at the forefront of Gosford!

To celebrate this success further, Gosford Leagues Club Park took out the 2021 National Trust Heritage Award for Aboriginal Heritage as well as the Judges' Choice category. This was an important project for Darkinjung to be involved in as our rich culture can now be seen, embraced, and enjoyed by the whole community.

Darkinjung has once again proved itself a highly resilient force in the face of the many challenges confronted by all member organisations during the 2020/21 financial year.

While public health orders making it mandatory for us to close our office doors necessitating the postponement of some of our planned operations and events during this period, the organisation embraced new ways of achieving our strategic goals and strengthening and empowering our community for all generations.

We made the decision early on to radically increase our online presence to ensure we retained that all-too-important connection to our members and community. When we were prevented from gathering in person, we found other ways to communicate to ensure the growing momentum behind our cultural, historical and educational offerings was not disrupted.

Our sustained efforts in this area have resulted in Darkinjung continuing to enjoy an increasingly significant profile within the Central Coast community as well at regional, state and national levels.

Darkinjung's key strategic priorities remain:

- To strengthen and empower our community now and for future generations;
- To maintain and share our knowledge for future generations by preserving, protecting and celebrating connection to our Country;
- To create opportunities for economic development and future prosperity through strong investment.

It is thanks to the enormous input from the efforts of our many members, board and executive team that Darkinjung is now in the position to announce significant progress in our development timeline over the past 12 months.

In January we welcomed our new chairperson Danielle Captain-Webb whose background in public interest advocacy has led us to identify substantive institutional, structural, and collaborative reform as a key priority for us in the months ahead. Mrs Captain-Webb replaced outgoing chairperson Matthew West who resigned from the Board in December 2020 to pursue other opportunities.


We would like to take this opportunity to acknowledge the tremendous contribution Mr West made to both Darkinjung and the Central Coast community as a whole.

Our constructive relationship with the NSW Government has allowed us to make significant progress with our plans to develop and implement the Darkinjung Delivery Framework, a pipeline of sites that we have prioritised to realise our economic, social, cultural and conservation aspirations.

In total there are four separate proposals – Lake Munmorah, Kariong, Somersby and Wallarah, involving around 331.5ha of land – now at various stages of assessment.

It has been a busy year of consolidation and the next 12 months is shaping up to be even more eventful, with the focus on sustaining the Local Aboriginal Land Council financially, consolidating our asset base, and ensuring the continued delivery of benefits to our Members.



The last 12 months has been a challenging one but also one I which Darkinjung has taken head on, it gives me enormous pride to have witnessed the resilience, perseverance and courage of those in our organisation to meet the challenges head on. As with most other member organisations, the past year has seen us ride the turbulent wave that is the COVID-19 pandemic and the profound impact it has had on the day-to-day running of our Land Council and challenged Membership participation.

Darkinjung continued to embark on its core business in an environment where we have also had to contend with misleading claims about our development proposals, address public scrutiny about Darkinjung's cultural authority. Yet rather than set us back, these challenges have only served to make us a stronger, fitter and more nimble organisation than ever before.

The leadership demonstrated by the Board of Directors – in particular Darkinjung Chairperson Danielle Captain-Webb, her predecessor Matthew West and the commitment and dedication given to the Darkinjung members, ensured we were in the best

possible position to meet our objectives as both a community and a business. Our drive to ensure our Country's sacred indigenous heritage is more broadly acknowledged took a significant leap forward when we became the first in Australia to be acknowledged through signage connecting road users to Country as a means of reinforcing the unique and intrinsic connection our people have to Country.


With many of our suburbs, streets and waterways named after Europeans, our call for some to be changed back to their original Aboriginal name - especially those linked with atrocities committed by early settlers on our people - is also well on its way to being heeded. In addition, we placed our traditional cultural burning practices more into the community's consciousness and we stand proudly witnessing the way the community is embracing the stunning new regional play space in Gosford that boasts such a strong Darkinjung footprint.


We took a major step on the path to reconciliation when we signed a Memorandum of Understanding with the 5 Lands Walk, reflecting the cultural significance of this literal and figurative journey for First Nations People. Wherever possible, we also did what we could to honour, celebrate and support Members, and to acknowledge and pay our respect to those who have gone before us whilst recognising their contribution to our people and community.

This was evidenced through the rollout of our care relief programs, our involvement with International Women's Day and Seniors Week. Moving forward, we will continue to ensure this spirit of community and giving remains at the heart of all that we do and who we are. I have no doubt that the coming year shall present many more challenges to grapple with, but also fabulous opportunities to seize. As an organisation, we eagerly await the chance to further demonstrate to Members and other interested parties our internal and external fortitude as well as our unwavering commitment to our cause.




DARKINJUNG MANAGEMENT STRUCTURE





Provide and secure affordable housing and accommodation for Members and the Aboriginal Community	Darkinjung continues to provide and manage affordable housing to its Members and currently has 28 properties occupied through the Affordable Rental Program. Under the current program, Members can apply for the following housing options: 4 bed single dwelling 2 bed dual occupancy dwellings (elders accommodation only Darkinjung has also implemented a policy of allowing Members first right of refusal to purchase any forthcoming land releases owed by Darkinjung and is in the process of developing a rent to buy policy for members. Darkinjung has commenced a scoping of all its affordable housing properties to assess what repairs and maintenance works are needed, with a view to complete these within the next few months	These benefits are ongoing pending Board direction and approval
2. Identify opportunities to improve and advance the wellbeing of our Elders	The proposed seniors living development at Blue Haven has been granted Development Approval through Central Coast Council. 


EMERGENCY RELIEF FUND



DARKINJUNG FIRST TO RECEIVE SIGNS

The unique and intrinsic connection the Darkinjung people have to Country here on the Central Coast has been highlighted by a new pilot program implemented by Transport New South Wales (TNSW). Our Country has been chosen as the one of the first in the state to receive a series of six unique road signs connecting road users to Country. The signs were revealed during a special unveiling attended by DLALC, with deputy chairperson Tina West speaking at the event where she revealed the board had worked closely alongside TNSW to determine that Bushells Ridge, Catherine Hill Bay, Cheero Point, Doyalson, Empire Bay and Ourimbah were the best locations for the signage to appear. Tina said the signs will help to foster a greater understanding of just how special this place among all people who live, work or are just visiting here and the shared responsibilities we all have to understand Darkinjung Country and care for its environment, culture and heritage for all the generations to come. Transport for NSW is continuing to develop this pilot program and will work closely with other Aboriginal Nations to roll out similar signs across the State.









Draft Aboriginal Cultural Heritage Bill – Darkinjung submitted their key concerns on several areas of the bill regarding Aboriginal cultural ownership of tangible and intangible cultural heritage values in New South Wales. Illegal access continues to be a major burden on Darkinjung lands. Dumping, four-wheel driving, and fire are all high risks which continue. In 2019, Darkinjung underwrote considerable expenditure to eliminate access points, this included barriers, surveillance In 2015, works began on development of a residential site that had a registered midden site at Booker Bay. LAND ACQUISITION, MANAGEMENT AND DISPOSAL

During the financial year of 2021

Darkinjung did not purchase or dispose of any land holdings

HERITAGE & SITE PROTECTION

Culture and Heritage staff have undertaken a number of projects to protect and conserve Aboriginal cultural heritage with organisations such as National Parks and Wildlife staff and Forestry Corporation staff. This has focussed on sites with high visitation sites such as Bulgandry Aboriginal Place in Brisbane Water National Park. Another project in Ourimbah State Forest to remove illegally dumped cars. The dump site was adjacent to a number of Aboriginal cultural sites. An exclusion zone was established and this was overseen by Darkinjung LALC in partnership with Forestry Corporation. In addition to this work, Darkinjung has


also undertaken cultural heritage surveys on commercial development projects across Darkinjung Country as well as routine inspections of cultural heritage sites for other commercial partners such as Centennial Mine at Mandalong. Darkinjung LALC was successful in receiving a grant of \$13,000 from the Aboriginal Fishing Trust Fund to run four cultural fishing camps for young people. Due to COVID these have not been able to be undertaken but it is anticipated that they will be conducted over the spring/summer of 2021/22. Darkinjung LALC has also been successful in receiving a grant of \$30,000 from Central Coast Council. This is to undertake environmental improvement works in the Tuggerah Lakes catchment and is funding provided from the Commonwealth Government's Environmental Restoration Fund.

MANGROVE MOUNTAIN CULTURAL FACILITY


Darkinjung continues to work to achieve a Cultural Education Facility at Bells Road, Mangrove Mountain. This facility is awaiting Occupancy Certificate from Central Coast Council. The area has been cleared for traffic flow and parking.





BUSINESS, FINANCE & ECONOMIC ENHANCEMENT



LAKE MUNMORAH

A proposal for the rezoning of land to R2 low density residential, R3 medium density residential and E2 conservation Lands. In the second half of 2020, under the Aboriginal State Environmental Planning Policy and Darkinjung's Interim Development Delivery Plan, responsibility for this planning proposal was transferred from the Central Coast Council to the NSW Department of Planning, Industry and Environment alongside the Hunter and Central Coast Regional Planning Panel.

Changes in development plans following government agency consultation saw the expected yield for this site increase from approximately 400 to 600 residential lots. Government agency consultations have taken longer than anticipated, delaying public exhibition of the planning proposal until the second half of 2021. Pending a positive determination of the planning proposal, rezoning of this site should be completed in the first half of 2022.

KARIONG

A proposal to rezone a portion of land from E2 conservation to R2 low density residential. 'The Hunter and Central Coast Regional Planning Panel decided in the first half of 2020 that this site had both strategic and site merit. The planning proposal is currently with the NSW Department of Planning, Industry and Environment for further assessment. Government agency consultations have taken longer than anticipated, delaying gateway determination of the planning proposal until the second half of 2021. The purpose of a gateway determination is to ensure that sufficient justification exists to proceed with a planned development.

WALLARAH

This was a proposal to rezone 89 Ha of land from RU6 Transition to part E2 Environmental Conservation (44 Ha), and part IN1 Industrial General (45 Ha). The planning proposal was finalised by the NSW Department of Planning, Industry and Environment in the second half of 2020.


The next step for this development is to prepare a development application for sub-division of the land. This could be carried out by Darkinjung LALC or via a joint venture partnership with an independent developer.

SOMERSBY

A proposal to rezone RU2 land to part E2 environmental conservation and part E3 environmental management, changing lot size to 40Ha for land zoned E2 and 2Ha for land zoned E3. The planning proposal received a positive gateway determination in the first half of 2020. A small amount of further environmental land assessment is required in order to prepare the planning proposal for public exhibition. Darkinjung LALC is currently working to address prohibitive biodiversity offsetting requirements for this site before seeking to finalise the planning proposal.



LATEST NEWS





BLUE HAVEN SUPPORTED LIVING

The DA for Lots 329 and 330 Colorado Avenue, Blue Haven was approved on 27th November 2017. The Board have requested funding from external sources for the construction of the development, and is well placed on Darkinjung's priority agenda.

NATIVE TITLE

On 30 October 2020, Darkinjung lodged a non-claimant application with the Federal Court of Australia (FCA). This application relates to 18 sites around the Central Coast totalling approximately 77 hectares. Darkinjung expects the FCA to deliver its judgement on the application around January 2022.


NATIVE TITLE & TRADITIONAL OWNERS

In 2013, the Awabakal and Guringai people filed a native title application in the Federal Court of Australia asking that their traditional rights and interests be recognised over Crown land and waters on the Central Coast of New South Wales. This claim was discontinued on 28 June 2017.

Since 1st July 2020, 15 Aboriginal Land Claims were granted to Darkinjung by the Department of Industry and Environment (Formerly, Crown Lands).









DARKINJUNG FUNERAL FUND EXPENDITURE
